



PARENT PLEDGE

We understand that San Luis Obispo Christian School (SLOCS) is an institution of Christian education whereby we learn to see things as God sees them. Its goal is to promote obedience to Christ in the spiritual, intellectual, physical, and social development of each child so that, "*...in all things He might have preeminence*" (*Colossians 1:18b*).

We are personally in agreement with and are committed to the SLOCS vision statement.

We understand that our child will be required to participate in the Pledge of Allegiance to the American flag, scripture memory work, chapel services, and prayer.

We understand the standards of San Luis Obispo Christian School do not tolerate profanity, obscenity in word or action, dishonor to God or the Word of God, or disrespect to SLOCS staff, parents, and students.

We recognize that SLOCS may have standards that go beyond some of our personal attitudes and opinions as individuals, but we willingly accept the responsibility to uphold school standards, rules, and regulations.

We understand that the prescribed student uniform must be worn each school day unless otherwise specified.

We agree to make tuition payments by the fifth of each month.

We understand our child must abide by the SLOCS rules dealing with the responsibilities he/she must uphold in and out of the classroom. Furthermore, we hereby invest authority in SLOCS to discipline our children according to school policy.

We agree that if our child should become involved in any problems with SLOCS staff or students, we shall cooperate in every way, through prayer and understanding, to solve such problems.

We agree that at least one parent or guardian will attend the parent meetings and fulfill the monthly parent participation or fee requirement.

We understand that not complying with the standards of San Luis Obispo Christian School, as set forth in this Pledge, may be justification for the removal of our child from school.

PARENT PLEDGE

I understand and agree to the following policies and regulations:

- there are no refunds on registration or curriculum fees
- to meet all school financial obligations punctually
- to permit my child to take part in all school activities, including field trips, sports activities, and school sponsored trips away from school premises
- the necessity of discipline for the welfare of each student and the entire school
- to permit my child’s teacher and/or other agent of the school to make and enforce classroom regulations in a manner consistent with Christian principles and discipline set forth in the Scriptures
- to hold the school and its agents free from any liability because of any injury or alleged injury to my child
- to not hold the school or its agent at fault and to pay any attorney fees, court fees, damages or other costs that the school or its agents should incur for any legal action against the school or its employee or agent, on my child’s behalf

This Statement of Cooperation will be in effect for as long as my children attend San Luis Obispo Christian School.

Should my home or marital status change, it is my responsibility to update my Statement of Cooperation and deliver it to San Luis Obispo Christian School.

Our signatures below indicate our consent and submission to all governing policies of SLOCS. It is understood that the services of the school are engaged by mutual consent, and that either the school, or we, reserves the right to terminate any or all services at any time. Admission to San Luis Obispo Christian School is a privilege, not a right.
